Major academic responsibilities

STRATEGIC ACADEMIC LEADERSHIP AND CITIZENSHIP

I have undertaken most of the main administrative and leadership responsibilities throughout my career, with a focus on academic and research leadership and strategic internationalisation.

Hong Kong: Heading a famous department

During my period in Hong Kong (August 2019- August 2024), I undertook a complex range of functions in my capacity as Head of the Department of Government and International Studies. I made a major contribution to the life of the GIS department, the Faculty of Social Sciences and in raising the international profile of Hong Kong Baptist University. I would highlight the following contributions:

Academic leadership: I provided firm and purposive academic leadership for the GIS department. I took control of the RAE 2020 at a very late stage and facilitated a very honorable performance (especially in relation to impact). I spearheaded the effort of internationalization, both in terms of dual degrees, as well as by the organization of a successful conference on Covid 19, which attracted participants from Overseas (UK, France, Australia, Singapore) as well as from Hong Kong. The conference attracted funding (IoC, Hung Hin Shiu Charitable Foundation 孔憲紹慈善基金贊助 \$100,000) and external publicity (for example, South China Morning Post). It also testified to good linkages with the external world. It obtained funding, produced two major reports and produced a special issue of a journal. In addition, I was involved as Co-PI (R2002-20F) and Co-I (GRF 12609918) on separate RGC projects. I spearheaded the successful Trust in the Smart City project (RC-FNRA-SOSC-19/20-01), involving workshops with major external partners and the conduct of a territory-wide survey implemented by the leading agency PORI.

Administrative and educational leadership. I piloted dual degrees with Bordeaux and Lyon through their final stages. I secured the appointment of seven new colleagues, five at Assistant Professor level (Yuen, Shim, Scicluna, Li, and Lee), a Talent 100 chair (Scully) and two lecturers (Lebayle and Yew). I successfully accompanied the substantiation of four colleagues. I set in motion three task and finish groups, reporting on the Curriculum, RPG and Internationalisation. I thoroughly rationalized and re-organized the governance of GIS, ensuring that each colleague has a recognizable function and attempting to introduce a flatter, more participative form of management. I encouraged colleagues to bid for grants, prizes and distinctions.

Outward facing leadership. In 2019, I revived the GIS External Advisory Group; we held a very fruitful meeting at the German Consul's office in December 2019, followed by a similarly successful meeting at the French consul's office in March 2021. Not only did I revive the external advisory committee, but I also organized four events in 2021 for the 25 years of GIS at very short notice. We strengthened our links with the networks of consulates present in Hong Kong, as well as with think tanks within and beyond the SAR. I organized a major event to mark our 25th anniversary that involved leadings figures in the international community, as well as Hong Kong alumni and current students. We have maintained contact with a network of international partners, as befits our department. Finally, we moved to create two alumni associations, for European Studies and Government and International Studies students.

Research leadership. The result of the 2021 Research Assessment Exercise (RAE) was very satisfactory for my department, GIS, representing a major increase in world class (15%) and internationally recognized (36%) research outputs. I personally wrote the impact statement and supervised and edited Prof. Cabestan's impact case study. I introduced an internal system of research mentoring. Consistent with my preference for a flatter style, I delegated major research responsibilities to a Standing Group on RAE 2026. My last act as HoD was to write the draft environment statement for the 2026 RAE in Hong Kong, which served as a template for the Social Sciences Faculty.

Lyon: Strategic internationalization

From the time of my arrival on secondment in Lyon in 2015, I was actively involved in Strategic Internationalisation.

2015-2016. This took the form, first, of being the Lyon representative in the trans-Atlantic Leading Cities network (Boston, Vancouver, Barcelona, Lisbon, Hamburg, Zapopan and Lyon), involving close contact with representatives of the municipal governments, civil society associations, businesses and universities of these cities. Smart City occupied centre-stage in this network.

From June 2016- August 2019, I was Director of Strategic Internationalisation for Sciences Po Lyon. In this capacity I sat on the School's management committee and on the University of Lyon's International Committee. I was also an elected representative on the Governing Council of Sciences Po Lyon (Conseil d'administration) as well as elected member of the Scientific Committee of the TRIANGLE research laboratory. In these various capacities I completed a review of the School's strategic priorities in the field of internationalization and been leading negotiations in relation to new double degree programmes. Cardiff University, 1999 -: Steering Research and Training

I was appointed to Cardiff in 1999 as a Professorial Research Fellow, in an open competition. The focus of my administrative responsibilities in Cardiff was on steering research and postgraduate training. I participated very actively in School administration, first as Chair of the Research Committee (1999-2002) and a member of the directorate; latterly as Director of Postgraduate Research (from 2004 to 2009). From 2010-13, I was part of the REF committee and I also served as Impact Champion.

I occupied important positions while at Cardiff University in 1999. From 1999 to 2002, I was Chair of the Research Committee in the Cardiff School of European Studies. This was a major charge, one that involved, amongst other responsibilities, overseeing the School's Research Assessment Exercise return in 2001, and managing the School's research budget. I was closely involved with planning the School's successful RAE submission: during my period as Chair of the Research Committee, European Studies in Cardiff rose from a 4 to a 5 grade ('internationally excellent'). I have acquired considerable exercise in preparing teams for research evaluation, including implementing systems of mentoring, monitoring and personal career development. I have also served on national (ESRC) and international (CNRS, ANR, FNRS) Scientific Council committees, and been on the European Commission list of SOCRATES experts.

From 2004 - 2009, I was Director of Postgraduate Research in the School of European Studies at Cardiff University. This major responsibility involved: defining and implementing a post-graduate research training programme in the Social Sciences and the Arts and Humanities; developing a system of mentoring PGR and younger academic staff; training potential supervisors; co-ordinating training provision with other Schools within the university and external networks. I wrote and steered the School's successful bid to lead a Language-Based Area Studies pathway in the All Wales Doctoral training centre.

Other responsibilities included being the School's Research Ethics Officer. In this capacity, I defined and implemented a research ethics procedure for all research carried out within the School of European Studies (from undergraduate dissertations to staff research). Managing such a procedure requires tact and persuasion, qualities I value above all others.

From 2004-13, I was co-chair (with Kenneth Dyson, FBA) of the European Governance, Identity and Public Policy research unit (EGIPP), arguably then the leading research group in the Cardiff School of European Studies. EGIPP's comparative advantage lay in its in-depth expertise on the leading EU states (France, Germany, Italy, Spain, the UK), its distinctive strengths in language-based area studies (and ESRC DTC recognition) and its close linkage with the European Commission representation in Wales. In 2011-2012, I was part of a successful Commission-funded seminar series on 'European Economic Governance: lessons for the UK and Wales'.

From 2006-10, I was co-chair (with Daniel Wincott) of the Wales Governance Centre, and I organized several high-profile conferences under the auspices of the WGC. The WGC aims to be a primary national and international reference point concerning the political and legal implications of the creation and growth in the activities of the National Assembly for Wales and Welsh Government; and the development of other equivalent institutions and relationships in the UK and internationally.

Finally, I was the Cardiff-Bordeaux Scheme co-ordinator and ERASMUS-MUNDUS link person. Anticipating the Bologna process, I introduced a joint degree-diploma programme between Cardiff University and the Bordeaux Institute of Political Studies, the first of its kind in the UK. The scheme has been running continuously since 2002.

Bradford University, 1995-1999: Head of Politics and ERASMUS links

Within the Department of European Studies at Bradford, I also carried out important administrative and leadership responsibilities. From 1997-99, I was head of the Politics Section within the department (with responsibility for six colleagues). As Head of the Politics section, responsibilities including those of liaising with external examiners, chairing the staff-student committee and course development. I was also SOCRATES exchange officer, managing a complex set of relationships with SOCRATES and ERASMUS partners. While I was at Bradford, the department obtained a 5 in the 1996 RAE. At Bradford University, I also introduced new courses on Comparative European Politics and French Politics.

Keele University 1989-1995: Comparative European Politics and the Keele European Research Centre

While at Keele, I was co-director of the Keele European Research Centre, and co-ordinator for Comparative European Politics.
